## SB1076 does NOT have strong protections

Section 1(5) ANOTHER person may "communicate" on behalf of the patient.

Section 1(6) permits ONE session with a social worker to classify as "counseling".

Section 1(20) permits ANY person to administer the experimental drug combination to the patient.

Section 1(21) includes treatable illnesses like DIABETES as a "terminal illness".

Section 7 permits VIRTUAL visits for examination and counseling.

Section 9(6) permits ANOTHER person to access the deadly drugs.

Section 10 does NOT require physicians to accurately list cause of death on certificate.

Section 12(d) forbids prosecution of ANY person who administers the experimental drug combination to the patient.

Section 13(c)&(d) requires ALL hospitals to be complicit.

Secs. 14(e) & 19 provide IMMUNITY to doctors and pharmacists based on "good faith".

Section 16 protects ANY person who "influences" the patient.

Section 25(e) EXCLUDES all data collected from the Freedom of Information Act.

The bill provides no restriction against ingesting drugs in public or a way to protect first responders.

The bill permits doctors to recommend assisted suicide instead of waiting for patient initiative.

The bill does not require competency at the time of ingestion, nor that the patient administer the drug combination themselves.

According this bill, a "qualified patient" can have depression so long as it is not impairing his/her judgment.

A patient could be consuming medications for depression and actually be suicidal due to depression and/or medications for depression.
